Having achieved the performance requirements specified in conformity assessment report No. **2023AT6033UE** and the PPE's Technical Documentation.

### Description of the PPE:

The PPE model ATLAS PLUS Harness consists of a fall arrest harness to be used for the prevention of falls from heights.

The model incorporates comfort padding on the shoulders, waist and leg loops. It has two anchorage points, on the chest and back, consisting of D-rings.

It comes with a positioning belt, which has two positioning D-rings. For belt adjustment, two locking buckles and quick adjustment are used. These buckles are also housed in the leg loops and on one shoulder, in order to regulate the length of the straps.

The upper part of the PPE and the lower part are joined by an automatic connector, which joins the parts thanks to the termination of both parts in textile gauzes, which are protected by a plastic. The lower textile loop incorporates an O-ring.

The model is marketed in black ribbon and padding and red thread.

The materials that form the PPE, are described in the conformity assessment report nº **2023AT6033UE**.

The PPE is available with the following variants:

It incorporates the variant ARNES ATLAS, where it differs from the model ARNES ATLAS PLUS in the elimination of the espalier.

It shall be the manufacturer's responsibility to provide specific information of this certificate and the tested levels of protection.
